- A. CLIENT CALLS THE COACH AT THE SCHEDULED TIME.**

1. As a client, I understand and agree that I am fully responsible for my physical, mental, and emotional well-being during my coaching calls, including all of my choices and decisions.
2. I understand that the coaching is designed to facilitate the development of personal, professional, or business goals, and to create and execute a strategy/plan for achieving those goals.
3. I acknowledge that coaching is a comprehensive process, and that the success of this coaching program depends upon my commitment and openness to the process. I understand that the coaching process may involve all areas of my life, including work, finances, health, relationships, education, and recreation. I acknowledge that deciding how to handle these issues, incorporate coaching into those areas, and implement my choices is exclusively my responsibility.
4. I am committed to following my coach's guidance, and I will participate fully in the action plan he/she provides for me. I also agree to abide by the scheduled session times that I have with my coach. I agree to call my coach at the agreed upon scheduled session time and at the agreed upon number he/she has provided for me.
5. I understand that coaching does not involve the diagnosis or treatment of mental disorders. I understand that coaching is not a substitute for counseling, psychotherapy, psychoanalysis, mental health care, or substance abuse treatment, and I will not use it in place of any form of diagnosis, treatment, or therapy.
6. I agree that if I am currently in therapy or under the care of a mental health professional, that I have consulted with the mental health care provider regarding the advisability of working with a coach, and that this person is aware of my decision to proceed with the coaching relationship.
7. I understand that my information will be held confidential by my coach unless required by law or by my written permission.
8. I understand that coaching is not to be used as a substitute for professional advice by legal, medical, financial, business, or other qualified professionals. I will seek independent professional guidance for legal, medical, financial, business, or other matters. I understand that all decisions in these areas are exclusively mine, and I acknowledge that my decisions and my actions regarding them are my sole responsibility.
9. I acknowledge that I will give 24 hours notice if I need to cancel or reschedule the time of our prescheduled phone coaching session. If I do not give 24 hours notice to cancel or reschedule the phone coaching session, the coaching call will be forfeited. I understand that there will be no refund for the call, and if I need to make up that particular session, there will be a separate fee for it.
10. I understand that if I do not cancel in a timely manner on a regular basis, that the coaching relationship will be terminated. I shall not be relieved of any obligations to pay fees due to the termination of this agreement.
11. In no event shall Your Winners Image LLC be liable to me for any punitive, incidental, or consequential damages of any kind in connection with this agreement.
12. My coach shall not be held responsible for any consequences, including but not limited to financial, personal, employment, or other losses arising out of decisions or actions I make as a result of the services provided by Your Winners Image LLC.
